**AGREED ORDER ON PLAINTIFF'S MOTION TO COMPEL COMPLIANCE  
WITH TERMS AND CONDITIONS OF CLASS ACTION SETTLEMENT**

This cause came before this Court pursuant to Plaintiff's Motion to Compel Compliance with Terms and Conditions of Class Action Settlement ("Motion"), and Defendant's, Nova Southeastern University, Inc., response thereto. Upon agreement of counsel, the Court hereby enters the following Order, Granting in Part and Denying in Part said Motion, which amends the Final Order Approving the Class Action Settlement only to the extent explicitly stated herein, and therefore FINDS, ORDERS and ADJUDGES as follows:

1. Claims forms shall be mailed to Class Members within 14 business days of entry of this Order. This shall allow sufficient time for said forms to be translated into the languages previously agreed to by the parties (i.e. Spanish and Creole).
  
2. Class Members shall have 90 days to submit their claims forms, in the manner previously set forth in the Final Order approving Class Action Settlement.
  
3. All settlement checks issued to the Class Members pursuant to this Class Action Settlement shall be good for 120 days.

4. A final accounting will be submitted by NOVA and/or its chosen Claims Administrator to the Court following a 120-day period during which settlement checks shall remain good/valid. The final accounting shall not require a subsequent motion, and shall be submitted pursuant to this Order.
